研究所員の活動と業績(2020-2021) Activities and performance of each staff(2020-2021)

Vesselin Popovski (Professor, School of International Peace Studies)

1. Kakenhi Application

In October 2021 submitted a single-authored 'Category C 'application for Kakenhi grant on the topic of 'Sustainability Impact of Mega Sport Events'. The proposal was triggered by analyzing the ambition of the Tokyo Olympics 2020 to serve as a future model for sustainable Olympics. The research will comparatively examine how big cities have developed after hosting the Olympics and Commonwealth Games. The project aims at several case studies from previous Olympics: London 2012 and Rio 2016; and the Commonwealth Games in Delhi, Birmingham, and Glasgow, and these games' impact on the cities developments – both positive and negative. The main aspects of city life to be analyzed are: green economy infrastructure, renewable energy, city transportation, effective electricity, waste management, etc.

The project runs for three years 2022-2025. The plan is to have several webinars, bringing together experts from many countries who have undertaken research to share their latest findings. The purpose is to deliberate and analyze the data and publish the latest academic knowledge in an edited volume

The methodology includes documentary research, conceptualization, correspondence with experts, data collection, observation, analysis, deliberation on policy decisions, and recommendations how to achieve sustainability in post-Olympic cities. The expert workshops will be followed by larger public events, utilizing the presence of world-class experts to share with Japanese stakeholders the latest knowledge and impact in both developed and developing countries. The research will exemplify variety of

approaches to sustainability, showing how some cities may plan for higher ambitions with the flexibility to adjust those commitments down, if methods are not working. Other cities can make modest commitments first, and then adjust those up, if they find the methods working better than expected. The research will use various scientific sources, compare and verify data from governments and business actors and civil society organizations. Experts will share findings with larger audiences and receive broad feedback.

2. Publications

In 2021 I completed the book 'Fulfilling Sustainable Development Goals' (Taylor & Francis 2021), a co-edited volume with Prof. Nicholas Robinson and Dr. Narinder Kakar from the Global Centre of Environmental Legal Studies, Elizabeth Haub School of Law, Pace University, New York. The book is one of the most comprehensive ever collection of chapters on the progress (or lack of) in implementing the SDGs. This book ambitiously addresses all 17 SDGs and focuses on the most crucial element – the implementation. This is the first publication to discuss the impacts of Covid-19 on all 17 SDGs and to offer recommendations how to achieve the Agenda 2030. I authored two chapters, on SDG-10 (Rising Inequality) and SDG-13 (Missing Climate Action), pointing to the insufficiency of state pledges and commitments and offering potential advise towards more ambitious implementation. I also co-authored the chapter on SDG-1 (Eradicating Extreme Poverty), the Preface and the Concluding chapter. We launched the book at the IUCN Annual Meeting in Marseille and at the COP26 of the UNFCCC in Glasgow in November 2021.

I published the article "Post-Pandemic Governance" in the European Public Policy Journal (internet journal). This publication listed five tests, that the Covid-19 pandemics presented and challenged the global governance. These are: test on leadership, test on international co-operation, test on medical capacity, test on human-human relationship, and test on human relationship

with nature. On a similar topic (in Bulgarian language) I published a chapter in a special issue of The Bulgarian Academy Social Science Journal "Infodemics and Covid-19".

I completed a chapter for a book comparing the European human rights mechanisms with the ASEAN system for respect and promotion of human rights, arguing that regional context and modalities are important to take into consideration in addition to the emphasis on the universality of human rights. In the Summer 2021 my chapter 'The Complex Life of Rafael Lemkin' in the book "The Dawn of a Discipline: International Criminal Justice and Its Early Exponents" (Cambridge University Press 2021), co-edited by Frederic Megret and Immi Tallgren, presented the personal tragic life of the Polish lawyer Rafael Lemkin and how it illustrates the origin and history of the crime of genocide.

I continued working closely with the Stimson Center, Washington DC, currently looking at how to create momentum to implement the UN Secretary General Antonio Guterres proposals from the Report "One Common Agenda". I took part in several e-consultations, incl. the Global Policy Dialogues convened by the Stimson Centre under the theme 'Renewal and Innovation of Global Governance', presenting and discussing five recommendations on peace and security and climate change. I started working on a revised policy brief 'New Security Councils" developing further the idea of creating Peacebuilding Council, Health Security Council and Climate Security Council, allowing a larger groups of states to be empowered to deal with non-traditional threats to peace and security. This brief is to be presented at the annual Doha Forum 25-28 Mach 2022.

I was invited to join the UN working group currently drafting the new UN 'Declaration on International Solidarity', to be proposed to the UN Member States for adoption at the 78th Session of the General Assembly of the UN. I took part in preparing the research background and in the webinars

deliberating the text of the Preamble and the articles in the substantive part of the Draft Declaration.

I delivered many online speeches at international conferences on a variety of topics: SDGs, UN Reform, Climate Change, Covid-19 impact on Human Development, the online challenge to Higher Education.

BOOK SUMMARY: This book is about state-building in war-torn African

countries. By using Sierra Leone, Liberia, and Côte d'Ivoire as case studies, the book sheds light on three critical cases in West Africa and furthers our understanding of the problematic nature of the postcolonial state and the wellbeing of its people. The book shows the challenges and opportunities for building peaceful and democratic postcolonial states in Africa. It addresses critical questions about the nature of the states, its vulnerabilities, the roles of the international actors on the development of the state, the mechanics of state-building, and the problems of institutional design. The overarching question in this study is: how can a multiethnic postcolonial war-torn country be transformed into a peaceful and democratic state? This question provokes other related questions about the case countries, namely: what are the causes of state collapse and the civil wars? How did the international community responded to state collapse and the civil wars? How were the causes of the civil wars addressed? What kinds of institutional arrangements have been established to ensure durable peace and inclusive democracy? Collectively, these questions not only address the reasons for problematic nature of the state in Sierra Leone, Liberia, and Côte d'Ivoire, but also point to the challenges and opportunities for building peaceful and democratic states.

 Abu Bakarr Bah & Nikolas Emmanuel (co-authored journal article, under review), "Migration Cooperation between Africa and Europe: Understanding the Role of Incentives".

ARTICLE ABSTRACT: The issue of mass migration and north-south relations are increasingly becoming complicated in international relations. In the case of the relation between Africa and Europe, irregular migration has become a major problem that is also breeding new forms of relations between Europe and Africa. This paper focuses on irregular migration into Europe through the Western Mediterranean

corridor from Morocco into Spain. More importantly, it examines the security concerns of mass irregular migrations, the efforts to manage and halt mass migration, and the forms of collaborations that have emerged between the European Union and Spain on the one hand and Morocco on the other hand. In particular, it focuses on the way incentives are deployed by Spain and the European Union to ensure that Morocco prevents irregular migrants from crossing into Europe. Overall, the paper raises two kinds of questions relating to the security issues in mass migration and the forms and nature of international collaborations to control mass migration from Africa to Europe. The paper shows the intersection of security issues with pragmatic collaboration in international relations. In terms of security, the paper ties mass irregular migration to human, cultural and state security concerns. In terms of the management of migration, the paper shows how various forms of incentives, in the forms of development assistance and diplomatic support, are used to get Morocco to enforce stringent anti-immigration practices. However, the system of incentives also creates a form of mutual dependency between Morocco and Europe in a way that enhances the agency of Morocco in its relation with Spain and the European Union as a whole.

Through our studies of crime and criminalization, we seek to engage in and further develop methodological, ethical and analytical concerns and possibilities surrounding these research themes by using a mixed-methods approach. The core group of researchers involved with the grant come from anthropology, sociology, political science and economics.

This project analyzes normative consequences of networked G20 governance, especially for the global economic policy agenda. The theoretical aspect of this study combines constructivist, discourse analytic, and sociological insights in analyzing G20 inclusivity practices and the forum's role in decentralizing global governance authority. This involves empirical research on G20 governance processes and networked relations, mainly during the annual rotating presidencies of Saudi Arabia in 2020, Italy in 2021, and Indonesia in 2022. The project

contributes to literature on global governance networks and the G20, including on normative effects of international practices. The main research product will be a forthcoming monograph, to be published by Routledge.
